PENGESAHAN *CONVENTION ON TEMPORARY ADMISSION*
(KONVENSI TENTANG PEMASUKAN SEMENTARA)

- A. RESERVATION ON ARTICLE 18 PARAGRAPH (1) OF ANNEX A, ARTICLE 5 PARAGRAPH (1) LETTER (A) OF ANNEX B.1, ARTICLE 4 OF ANNEX B.5, ARTICLE 6 OF ANNEX C *CONVENTION ON TEMPORARY ADMISSION*

The Government of the Republic of Indonesia, upon the Convention, hereby states:

1. Article 18 Paragraph (1) of Annex A, the provision of postal goods is reserved considering legislation relevant to postal goods has provided facilities on its implementation without application of Carnet System.
2. Article 5 Paragraph (1) Letter (a) Annex B.1 on import duties and taxes exemption upon clearance for home use without import prohibitions and restrictions on small samples is reserved considering the obligation to pay off import duties and taxes and to apply the provision of import prohibitions and restrictions on samples at the time of its importation in accordance with legislation.
3. Article 4 of Annex B.5 on obligation to grant temporary admission of scientific equipment, pedagogic material and welfare material for seafarers used on board ships without a Customs document or security being required is reserved considering monitoring process of goods traffic the documents or security are needed in accordance with legislation.
