ADJUSTMENT TO GOODS CLASSIFICATION SUBJECT TO PROHIBITION AND LIMITATION FROM EXPORT AND IMPORT BASED ON GOODS CLASSIFICATION SYSTEM

(Regulation of Minister of Trade of R.I Number 14/M-DAG/PER/2/2017, dated February 28, 2017)

WITH THE BLESSING OF THE ONE AND ONLY GOD
MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA

Considering:

- a. whereas, a new system on goods classification has been stipulated by the Government by Regulation of Minister of Finance Number 6/PMK.010/2017, concerning stipulation of System on goods classification and imposition of Import Duty on Imported Goods so that it is necessary to make adjustment to goods classification subject to Prohibition and Limitation from Export and Import based on the new system on goods classification;
- b. whereas, based on the consideration referred to in letter a and to improve effective supervision and operation of goods export and import subject to Prohibition and Limitation from Export and Import, it is necessary to stipulate Regulation of Minister of Trade on adjustment to Goods classification subject to Prohibition and Limitation from Export and Import based on the system on Goods classification;

DECIDES:

To stipulate:

REGULATION OF MINISTER OF TRADE ON ADJUSTMENT TO GOODS CLASSIFICATION SUBJECT TO PRO-HIBITION AND LIMITATION FROM EXPORT AND IMPORT BASED ON THE SYSTEM ON GOODS CLASSIFICA-TION.

Article 1

Classification of goods for export and import must justify with the description of the goods and Post Tariff/HS as specified in System of Goods classification Year 2017, as stipulated under Regulation of Minister of Finance on stipulation of system on goods classification.

Article 2

If no adjustment is yet made to Regulation of Minister of Trade that governs prohibition and limitation from export and import of goods description and Post Tariff/HS based on the System of Goods classification Year 2017, implementation of export and import of goods shall refer to the System of Goods classification Year 2017.

Article 3

Permits for export and import issued by the Ministry of Trade before March 1, 2017 not adjusted yet on the goods classification in Post Tariff/HS based on System of Goods classification Year 2017, survives untill expiry of the valid permits.

Article 4

This Regulation of Minister takes effect on March 1, 2017.

For public recognition, this Regulation of Minister shall be announced by placing it in the State Gazette of the Republic of Indonesia.
