STIPULATION OF PERCEPTION BANKS ACTING AS RECIPIENTS OF REDEMPTION MONEY IN THE FRAMEWORK OF EXECUTING TAX AMNESTY

(Decree of the Minister of Finance Number 600/KMK.03/2016, dated July 18, 2016)

THE MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA,

Considering:

- a. that pursuant to the provision of Article 1 point 14 of Law Number 11 Year 2016 on Tax Amnesty, perception bank is a commercial bank appointed by the minister to receive the remittance of state revenue and on the basis of the law is appointed to receive the remittance of redemption money and/or funds transferred into the territory of the Unitary State of the Republic of Indonesia in the framework of executing tax amnesty;
- b. that pursuant to the provision of Article 37 letter a of Regulation of the Minister of Finance Number 118/ PMK.03/2016 on the Implementation of Law Number 11 Year 2016 regarding Tax Amnesty, the Minister stipulates perception banks receiving the payment of the redemption money;
- c. that having regards to letters a and b, it is necessary to stipulate a decree of the Minister of Finance on Stipulation of Perception Banks Acting As Recipients of Redemption Money in the framework of executing tax amnesty;

In view of:

- Law Number 11 Year 2016 on Tax Amnesty (Statute Book of the Republic of Indonesia Year 2016 Number 131, Supplement to Statute Book of the Republic of Indonesia Number 5899);
- Regulation of the Minister of Finance Number 118/PMK.03/2016 on the Implementation of Law Number 11
 Year 2016 regarding Tax Amnesty;
- 3. Regulation of the Minister of Finance Number 99/PMK.06/2006 on State Revenue Module;

DECIDES:

To stipulate:

THE DECREE OF THE MINISTER OF FINANCE ON STIPULATION OF PERCEPTION BANKS ACTING AS RECIPIENTS OF REDEMPTION MONEY IN THE FRAMEWORK OF EXECUTING TAX AMNESTY.

FIRST:

The Minister of Finance shall stipulate perception banks acting as recipients of redemption money in the framework of executing tax amnesty as contained in the attachment, which constitutes an integral part of this regulation.

SECOND:

The appointment of the perception banks as meant in Dictum FIRST shall not reduce/prevent/delay/abolish the obligation of the perception banks in accordance with Bank Service Agreement as perception bank in the framework of the implementation of Treasury Single Account (TSA) of revenue.

THIRD:

The appointment of the perception bank acting as meant in Dictum FIRST shall start to apply as from the stipulation of this ministerial decree yup to March 31, 2017.

FOURTH:

The ministerial decree shall come into force as from the date of stipulation.
