

APPLICATION OF QUALITY CONTROL AND COST CONTROL ON IMPLEMENTATION OF NATIONAL HEALTH AND SOCIAL HEALTH SECURITY PROGRAM

Part Two

Requirements

Article 15

Requirement and procedure for registration of potential members of Team on Quality Control and Cost Control referred to in Article 5 shall mutatis mutandis apply for potential member of the Board of Medical Advisory.

Part Three

Procedure for Selection and Decision

Article 16

- (1) The Board of Directors of Health BPJS shall select and decide members of the Board of Medical Advisory that comply with the requirements as recommended by professional organization, medical experts organization, and Faculty of Medical Doctor of Indonesia.
- (2) Prior to processing decision, Health BPJS shall submit letter of commitment to selected potential member of the Board of Medical Advisory.
- (3) The selected members of the Board of Medical Advisory referred to in paragraph (2), shall be decided by means of:

- a. Decision of the Board of Directors of Health BPJS for Board of Medical Advisory in central part and
 - b. Decision of the Head of Regional Division of Health BPJS for Board of Medical Advisory of Province.
- (4) Service year of Board of Medical Advisory referred to in paragraph (3) is one (1) year effective as the date of decision.

Part Four

Function and Duty

Article 17

- (1) The Board of Medical Advisory as referred to in paragraph (1) is assigned the function as medical advisor for Health BPJS to guaranty health service for Participant of FKRTL.
- (2) In exercising the function referred to in paragraph (3), the Board of Medical Advisory is assigned the duties as cited below:
- a. recommend decision in the case of different perception between Health BPJS and FKRTL in technical medical service;
 - b. jointly with Team on Quality Control and Cost Control settle dispute on implementation of National Health Security; and
 - c. file unsettled dispute to the Board of Medical Advisory.

CHAPTER IV

CLOSING PROVISION

Article 18

This Regulation on BPJS Health takes effect on the date it is enacted.

For public recognition, this Regulation on BPJS Health shall be announced by placing it in the State Gazette of the State of the Republic of Indonesia.
