AMENDMENT TO REGULATION OF HEAD OF DRUGS AND FOOD SUPERVISION NUMBER 13 YEAR 2015 CONCERNING SUPERVISION OVER IMPORTED DRUG AND FOOD STUFF INTO THE TERRITORY OF INDONESIA

(Regulation of Drugs and Food Supervision of R.I Number 26 Year 2016, dated October 17, 2016)

Considering:

- a. whereas, coordination of supervision on imported Drugs and Food Stuff stipulated under Regulation of the Head of Supervisory Agency of Drugs and Food Number 13 Year 2015 concerning into the territory of the Republic of Indonesia, it is necessary to make adjustment to the latest provision on import;
- b. whereas, based on the consideration referred to in letter a, it is necessary to stipulate Regulation of Head of Supervisory Agency of Drugs and Food concerning Amendment to Regulation of the Head of Supervisory Agency of Drugs and Food Number 13 Year 2015 concerning Supervision on Imported Drugs and Food Stuff into the territory of the Republic of Indonesia;

DECIDES:

To stipulate:

REGULATION OF HEAD OF SUPERVISORY AGENCY OF DRUGS AND FOOD CONCERNING AMENDMENT TO REGULATION OF HEAD OF SUPERVISORY AGENCY OF DRUGS AND FOOD NUMBER 13 YEAR 2015, CONCERNING SUPERVISON ON IMPORTED DRUGS AND FOOD STUFF INTO THE TERRITORY OF THE REPUBLIC OF INDONESIA.

Article I

Add two (2) paragraphs, namely paragraph (2) and paragraph (3) to the provisions in Article 9 of Regulation of the Head of Supervisory Agency of Drugs and Food Number 13 Year 2015, concerning Supervison on Imported Drugs and Food Stuff into the territory of the Republic of Indonesia (State Gazette of the Republic of Indonesia Year 2015 Number 1374), so that Article 9 now reads as follows:

Article 9

(1) Drugs and Food Stuff which import thereof is as set forth in Attachment II constituting inseparable part of

this Regulation Head of Agency.

- (2) Other than the Drugs and Food Stuff referred to in paragraph (1), for the Drugs and Food Stuff referred to in Attachment IV constituting inseparable part of this Regulation of the Head of Agency, may be imported into the territory of the Republic of Indonesia.
- (3) If the HS Code mentioned in Attachment II as referred to in paragraph (1) and Attachment IV as referred to in paragraph (2) is different from the HS Code stipulated by the competent authority on Customs matter, the HS Code stipulated by the competent authority on Customs matter prevails.

Article II

This Regulation of the Head of Agency takes effect on the date it is enacted.

For public cognizance, this Regulation of the Head of Agency shall be announced by placing it in the State Gazette Republic of Indonesia.
