

# **THIRD ROUND OF AMENDMENT TO REGULATION OF THE INDUSTRY MINISTER NO. 34/M-IND/PER/3/2015 CONCERNING THE INDUSTRY OF FOUR-AND-MORE WHEELED MOTOR VEHICLES AND THE INDUSTRY OF MOTORCYCLES**

**(Regulation Of The Industry Minister Of The Republic Of Indonesia No. 22/M-IND/PER/3/2016 dated March 22, 2016)**

THE INDUSTRY MINISTER OF THE REPUBLIC OF INDONESIA,

Considering :

- a. that to ensure smooth realization, development and growth of motor vehicle industry, in accordance with the development of industrial technology, it is necessary to revise Regulation of the Industry Minister No. 34/M-IND/PER/3/2015 concerning the Industry of Four-and More-Wheeled Motor Vehicles and the Industry of Motorcycles;
- b. that based on the consideration as referred to in letter a, it is necessary to stipulate Regulation of the Industry Minister concerning the Third Round of Amendment to Regulation of the Industry Minister No. 34/M-IND/PER/3/2015 concerning the Industry of Four-and More-Wheeled Motor Vehicles and the Industry of Motorcycles;

#### Article I

Provisions in Article 37 of Regulation of the Industry Minister No. 34/M-IND/PER/3/2015 concerning the Industry of Four-and More-Wheel Motor Vehicles and the industry of motorcycles as already several times amended the latest by Regulation of the Industry Minister No. 73/M-IND/PER/9/2015 are amended as follows:

#### Article 37

This Ministerial Regulation shall come into force as from September 23, 2016.

#### Article II

This Ministerial Regulation shall come into force as from the date of promulgation.
