

AMENDMENT TO REGULATION OF THE HEALTH MINISTER NO. 889/MENKES/PER/V/2011 CONCERNING REGISTRATION, PRACTICE PERMIT, AND WORK PERMIT FOR PHARMACISTS (Regulation of the Health Minister of the Republic of Indonesia No. 31/2016 dated July 18, 2016)

BY THE GRACE OF ALMIGHTY GOD

THE HEALTH MINISTER OF THE REPUBLIC OF INDONESIA,

Considering :

- a. that Regulation of the Health Minister No. 889/Menkes/Per/V/2011 concerning Registration, Practice Permit and Work Permit of Pharmacists, it is necessary to adjust it to the legal development and need;
- b. that based on the consideration as referred to in letter a, it is necessary to stipulate Regulation of the Health Minister concerning Amendment to Regulation of the Health Minister No. 889/Menkes/Per/V/2011 concerning Registration, Practice Permit and Work Permit of Pharmacists;

In view of :

Law No. 23/2014 concerning Regional Government (Statute Book of the Republic Indonesia of 2014 No. 244, Supplement to Statute Book of the Republic of Indonesia No. 5587) as already several times amended the latest by Law No. 9/2015 concerning the Second Round of Amendment to Law No. 23/2014 concerning Regional Government (Statute Book of the Republic Indonesia of 2015 No. 588, Supplement to Statute Book of the Republic of Indonesia No. 5679);
4. Law No. 36/2014 concerning Health Workers (Statute Book of the Republic Indonesia of 2014 No. 298, Supplement to Statute Book of the Republic of Indonesia No. 5607);
5. Government Regulation No. 72/1998 concerning the Safeguard of Pharmaceutical Preparations and Health

DECIDES :

To stipulate :

REGULATION OF THE HEALTH MINISTER CONCERNING THE AMENDMENT TO REGULATION OF THE HEALTH MINISTER NO. 889/MENKES/PER/V/2011 CONCERNING THE REGISTRATION, PRACTICE PERMIT, AND WORK PERMIT FOR PHARMACISTS.

Article I

Several provisions in Regulation of the Health Minister No. 889/Menkes/Per/V/2011 concerning the Registration, Practice Permit and Work Permit of Pharmacists (State Gazette of the Republic of Indonesia of 2011 No. 322) shall be amended as follows;

1. Nomenclature which reads work permit shall be read and construed as practice permit.
2. Provisions in paragraph (2) Article 17 shall be amended so that the article reads as follows:

Article 17

- (1) Any pharmacist wishing to do pharmaceutical work shall hold a permit according to the place where the pharmacist works.
- (2) The permit as referred to in paragraph (1) comes in the form of:
 - a. SIPA for pharmacist; or
 - b. SIPTTK for pharmaceutical technical worker.

3. Provisions in Article 18 shall be amended so that it reads as follows:

Article 18

- (1) SIPA for pharmacist at pharmaceutical facility shall only be issued for 1 (one) pharmaceutical facility.
- (2) Exception to provisions as referred to in paragraph (1), SIPA for pharmacist at pharmaceutical facility can be issued for a maximum of 3 (three) pharmaceutical facilities.
- (3) If a pharmacist has held a pharmacy permit, the pharmacist can only hold 2 (two) SIPA at other pharmaceutical facilities.
- (4) SIPTTK can be issued for a maximum of 3 (three) pharmaceutical facilities.

4. Provisions in Article 19 are amended so that it reads as follows:

Article 19

SIPA or SIPTTK as referred to in Article 17 shall be issued by regency/municipal governments based on recommendations from authorized health officials in the regency/municipality where pharmacists conduct their practices.

Article II

This Ministerial Regulation shall come into force as from the date of promulgation.

For public cognizance, this Ministerial Regulation shall be promulgated by placing it in the State Gazette of the Republic of Indonesia.
