DETAIL OF FINANCIAL SHARING OF REVENUE FROM TOBACCO EXCISE BY PROVINCE/REGENCY/ CITY IN FISCAL YEAR 2016

(Regulation of the Minister of Finance Number 47/PMK.07/2016 dated March 24, 2016)

BY GRACE OF GOD THE ALMIGHTY

THE MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA,

Considering:

- a. that pursuant to Law Number 14 Year 2015 on State Budget of Revenue and Expenditure in Fiscal Year 2016 jo. Presidential Regulation Number 137 Year 2015 on Detail of State Budget of Revenue and Expenditure in Fiscal Year 2016, financial sharing of revenue from tobacco excise in Fiscal Year 2016 has been allocated;
- b. that pursuant to Article 66A paragraph (4) of Law Number 11 Year 1995 regarding Excise as already amended by Law Number 39 Year 2007, the finacial sharing of revenue from tobacco excise to provinces/ regencies/cities regulated by governors is executed by approval of the Minister of Finance;
- c. that pursuant to the provision of Article 24 paragraph (5) of Regulation of the Minister of Finance Number 250/PMK.07/2014 on the Allocation of Transfer to Region and Village Funds, the approval of the financial sharing of revenue from tobacco excise to provinces/regencies/cities recommended by governors to the Minister of Finance is stipulated by a regulation of the Minister of Finance;
- d. that having regards to letters a, b and c, it is necessary to stipulate a regulation of the Minister on Detail of Financial Sharing of Revenue from Tobacco Excise by Province/Regency/City in Fiscal Year 2016;

In view of:

DECIDES:

To stipulate:

THE REGULATION OF THE MINISTER OF FINANCE ON DETAIL OF FINANCIAL SHARING OF REVENUE FROM TOBACCO EXCISE BY PROVINCE/REGENCY/CITY IN FISCAL YEAR 2016

Article 1

- (1) The financial sharing of revenue from tobacco excise in Fiscal Year 2016 as set forth in Law Number 14 Year 2015 on State Budget of Revenue and Expenditure in Fiscal Year 2016 jo. Presidential Regulation Number 137 Year 2015 on Detail of State Budget of Revenue and Expenditure in Fiscal Year 2016 shall be amounting to Rp 2,796,355,150,000 (two trillion seven hundred ninety six billion three hundred fifty five million and one hundred fifty thousand rupiah).
- (2) The detail of the financial sharing of revenue from tobacco excise in Fiscal Year 2016 s meant in paragraph
 (1) by province/regency/city shall be contained in the attachment which constitutes an integral part of this ministerial regulation.

Article 2

Procedures for distributing the financial sharing of revenue from tobacco excise shall be done in accordance with the provision of legislation.

Article 3

The ministerial regulation shall come into force as from the date of promulgation.
