

PROCEDURE FOR STIPULATING X FACTOR SERVICE FOR ICE PROCUREMENT AT FISHERY PORT (Regulation of the Minister of Marine and Fishery of the Republic of Indonesia Number 7/PERMEN-KP/2016, dated March 10, 2016)

WITH THE BLESSING OF THE ONE AND ONLY GOD
THE MINISTER OF MARINE AND FISHERY
OF THE REPUBLIC OF INDONESIA

Considering:

Whereas, to implement the provision in Article 8 paragraph (2) of Government Number 75 Year 2015, concerning Type and Tariff of State Tax Income prevailing at the Ministry of Marine and Fishery, it is necessary to stipulate Regulation of the Minister Marine and Fishery concerning procedure to stipulating X Factor Tariff for ice procurement at Fishery Port;

In view of:

1. Law Number 20 Year 1997, concerning State Non-Tax Income (Statute Book of the Republic of Indonesia Year 1997 Number 43, Supplement to Statute Book of the Republic of Indonesia Number 3687);
2. Law Number 31 Year 2004, concerning Fishery (Statute Book of the Republic of Indonesia Year 2004 Number 118, Supplement to Statute Book

of the Republic of Indonesia Number 4433), as amended by Law Number 45 Year 2009 (Statute Book of the Republic of Indonesia Year 2009 Number 154, Supplement to Statute Book of the Republic of Indonesia Number 5073);

3. Government Regulation Number 75 Year 2015, concerning Type, and Tarif of State Non-Tax Income Tax prevailing at the Ministry of Marine and Fishery, (Statute Book of the Republic of Indonesia Year 2015 Number 225, Supplement to Statute Book of the Republic of Indonesia Number 5745);
4. Presidential Regulation Number 7 Year 2015, concerning Organization of State Ministry (Statute Book of the Republic of Indonesia Year 2015 Number 8);
5. Presidential Regulation Number 63 Year 2015, concerning Ministry of Marine and Fishery (Statute Book of the Republic of Indonesia Year 2015 Number 111);
6. Presidential Decree Number 121/P Year 2014, concerning Establishment and Appointment of

Minister of Manpower for Period Year 2014-2019, as amended by Presidential Decree Number 79/P Year 2015;

7. Regulation of the Minister of Marine and Fishery Number 23/PERMEN-KP/2015, concerning Organization and Work Procedure of the Ministry of Marine and Fishery (State Gazette of the Republic of Indonesia Year 2015 Number 1227);

DECIDES:

To stipulate:

REGULATION OF THE MINISTER OF MARINE AND FISHERY CONCERNING PROCEDURE TO STIPULATING A FACTOR TARIFF FOR ICE PROCUREMENT SERVICE IN FISHERY PORT.

Article 1

What is meant by Regulation of this Minister by:

1. X Factor shall be factor for price justification with due consideration of the price of. Among other things, salt, chemical substances, and machinery operations.
2. Fishery Port shall be place covering land and waters surrounding it with particular borders constituting place of the administrative activities and operational system of Fishery boats to bersandar, moor, and/or stevedore supported by navigation safety facilities and Fishery supporting activities.

Article 2

- (1) The nominal value plus X Factor Tariff of Ice Procurement Service at Fishery Port shall be computed based X Factor Tariff of Ice per kilogram as follows:
 - a. Samudera Fishery Port, Rp.200,00 + X Factor;
 - b. Nusantara Fishery Port Rp.150,00 + X Factor; and
 - c. Seacoast Fishery Port, Rp.150,00 + X Faktor.
- (2) The X Factor referred to in paragraph (1) shall be fixed with due consideration of:

- a. production capacity; and
- b. Fishery Port facilities.

(3) The Tariff for Ice Procurement Service at Fishery Port also applies for purchase of Warehouse or Factory for Ice.

Article 3

(1) The X Factor for Ice Procurement Service at Fishery Port referred to in Article 2 paragraph (1), covers the costs below:

- a. electricity or oil fuel;
- b. water;
- c. salt;
- d. cooling substance;
- e. lubrication;
- f. manpower; and
- g. maintenance.

(2) Electric Power Cost referred to in paragraph (1) letter a, shall be cost for electric power use expended to produce one (1) kg Ice based on Electric Power Basic Tariff (TDL) fixed by the Government.

(3) Cost for oil fuel referred to in paragraph (1) letter a shall be cost for the use of oil fuel expended to produce one (1) kg Ice based on the price fixed by the Government.

(4) The Water Cost referred to in paragraph (1) letter b shall be Cost for water expended to produce one (1) kg Ice based on the tariff in the respective area.

(5) The Salt Cost referred to in paragraph (1) letter c shall be Cost for Salt expended to produce one (1) kg Ice based on the price in the respective area.

(6) The Cooling Substance Cost referred to in paragraph (1) letter d, shall be Cost for using cooling substance such as, amoniac and freon to produce one (1) kg Ice based on the price in the respective area.

- (7) The Lubrication Cost referred to in paragraph (1) letter e shall be Cost for lubrication to produce one (1) kg Ice based on the price in each area.
- (8) The Cost for Manpower referred to in paragraph (1) letter f shall be Cost calculation for Manpower expended to produce one (1) kg Ice.
- (9) The Maintenance Cost referred to in paragraph (1) letter g is calculation of maintenance cost for machinery and equipment expended to produce one (1) kg Ice.
- (10) The Maintenance Cost referred to in paragraph (9) shall be computed 10 (ten) percent of the total costs expended as referred to in paragraph (1) letter a through letter f to produce one (1) kg Ice.

Article 4

- (1) The X Factor shall be the amount of all costs expended as referred to in Article 3 paragraph (1).
- (2) The X Factor for Ice Procurement Service shall be for the respective Fishery Port as referred to in ATTACHMENT constituting inseparable part of this Regulation of the Minister.

Article 5

This Regulation of the Minister comes to force on the date it is enacted.

For public cognizance, this Regulation of the Minister shall be announced by placing it in the State Gazette of the Republic of Indonesia.
