

# **HIGHER EDUCATION QUALITY GUARANTEE SYSTEM**

## **(Regulation of the Research, Technology and Higher Education of the Republic of Indonesia No. 62/2016 dated September 23, 2016)**

BY THE GRACE OF ALMIGHTY GOD

THE RESEARCH, TECHNOLOGY, AND HIGHER EDUCATION MINISTER OF THE REPUBLIC OF INDONESIA,

Considering :

That to implement Article 52 paragraph (3) and Article 54 paragraph (8) of Law No. 12/ 2012 concerning Higher Education, it is necessary to stipulate a Regulation of the Research, Technology and Higher Education Minister concerning Higher Education Quality Guarantee System;

In view of :

1. Law No. 12/2012 concerning Higher Education (Statute Book of the Republic of Indonesia of 2012 No. 158, Supplement to Statute Book of the Republic of Indonesia No. 5336);
2. Government Regulation No. 4/2014 concerning the Realization of Higher Education and the Management of Institutes of Higher Learning (Statute Book of the Republic of Indonesia of 2014 No. 16, Supplement to Statute Book of the Republic of Indonesia No. 5500);
3. Presidential Regulation No. 13/2015 concerning the Research, Technology and Higher Education Ministry (Statute Book of the Republic of Indonesia of 2015 No. 14);
4. Presidential Decree No. 121/P/ 2014 concerning the Establishment of Ministries and the Appointment of Ministers of the Working Cabinet for the 2014-2019 Period;
5. Regulation of the Research, Technology and Higher Education Minister No. 15/2015 concerning the Organization and Working Procedure of the Research, Technology and Higher Education Ministry (State Gazette of the Republic of Indonesia of 2015 No. 889);
6. Regulation of the Research, Technology and Higher Education Minister No. 44/2015 concerning the National Standard of Higher Education (State Gazette of the Republic of Indonesia of 2015 No. 1952);

**DECIDES :**

To stipulate :

**REGULATION OF THE RESEARCH, TECHNOLOGY AND HIGHER EDUCATION MINISTER CONCERNING HIGHER EDUCATION QUALITY GUARANTEE SYSTEM.**

**CHAPTER I****GENERAL PROVISIONS****Article 1**

Referred to in this Ministerial Regulation as :

1. Higher education quality is the level of appropriateness between the realization of higher education and the higher education standard, consisting of national higher education standard and higher education standard set by an institute of higher learning. .
2. Higher education quality guarantee system, hereinafter abbreviated into SPM Dikti, is a systemic activity to increase the quality of higher education in a well-planned and sustainable way.
3. Internal quality guarantee system, hereinafter abbreviated into SPMI, is a systemic activity of higher education quality guarantee system carried out autonomously by each institute of higher learning to control and improve the realization of higher education in a well-planned and sustainable way.
4. External quality guarantee system, hereinafter abbreviated into SPME, is an assessment activity carried out through accreditation to determine feasibility and achievement of the quality of study programs and institute of higher learning..
5. Higher education data base, hereinafter abbreviated into PDDikti is a collection of data on the realization of higher education from all institutes of higher learning integrated nationally.
6. Higher education national standard is a unit of standard covering national education standard and national standard of dedication to the public.
7. Higher education standard set by institute of higher learning is a number of standards at an institute of higher learning exceeding higher education national standard.
8. Institute of higher learning is a unit of education organizing higher education..

9. National Accreditation Agency for Institutes of Higher Learning, hereinafter abbreviated into BAN-PT, is an agency set up by the Government to conduct and develop the accreditation of institutes of higher learning on a self-reliant basis..
10. Self-reliant accreditation institution for study programs, hereinafter abbreviated into LAM, is an institution set up by the Government or the community to conduct and develop the accreditation of study programs on a self-reliant basis.
11. Ministry is a government apparatus dealing with government affairs in the field of higher education.
12. Minister is the minister dealing with government affairs in the field of higher education.
13. Directorate General is the Directorate General of Learning and Student Affairs of the Research, Technology and Higher Education Ministry.

#### Article 2

- (1) SPM Dikti is aimed at ensuring the fulfillment of higher education standard in a systemic and sustainable way so that culture of quality will grow and develop.
- (2) SPM Dikti functions as a means to control the realization of higher education by institutes of higher learning to create quality education.

### CHAPTER II

#### MECHANISM OF HIGHER EDUCATION

#### QUALITY GUARANTEE SYSTEM

#### Article 3

- (1) SPM Dikti consists of :
  - a. SPMI; and
  - b. SPME
- (2) The SPMI as referred to in paragraph (1) letter a shall be planned, realized, evaluated, controlled, and developed by institutes of higher learning
- (3) The SPME as referred to in paragraph (1) letter b shall be planned, realized, evaluated, controlled, and developed by BAN-PT and/or LAM through accreditation according to their respective authority.
- (4) The output of the application of SPMI by institutes of higher learning as referred to in paragraph t (2) shall

be used by BAN-PT or LAM to decide the accreditation status and ratings of institutes of higher learning or study programs.

**Article 4**

- (1) The planning, realization, evaluation, control and development of SPMI and SPME shall be based on higher education standard. .
- (2) The higher education standard as referred to in paragraph (1) consists of :
  - a. Higher education national standard; and
  - b. Higher education standard set by institutes of higher learning.
- (3) Higher education national standard shall be formulated and developed by the National Standard Agency for Higher Education and set forth in a Ministerial Regulation.
- (4) Higher education standard set by institutes of higher learning shall be formulated and developed by institutes of higher learning and set forth in a regulation of the leadership of institute of higher learning for state institutes of higher learning (PTN), or a regulation of the executing legal entity for private institutes of higher learning ( PTS), after being approved by the senate of institute of higher learning.

**Article 5**

- (1) SPMI has a cycle of activities consisting of :
  - a. setting higher education standard;
  - b. realizing higher education standard;
  - c. evaluating the realization of higher education standard;
  - d. controlling the realization of higher education standard; and
  - e. upgrading higher education standard.
- (2) The evaluation as referred to in paragraph (1) letter c shall be conducted through internal quality audit.
- (3) SPMI shall be implemented in all fields of activities of institutes of higher learning, namely :
  - a. academic field, covering education, research, and dedication to the public; and
  - b. non-academic field, including human resources, finance, facilities and infrastructures.
- (4) The activities as referred to in paragraph (3) are used to achieve higher education standard.
- (5) SPMI as a system shall be evaluated and developed in a sustainable way by institutes of higher learning concerned.

- (6) SPMI is set forth in the regulation of the leadership of institutes of higher learning for state institutes of higher learning (PTN) or the regulation of the operating legal entity for private institutes of higher learning (PTS), after being approved by the senate or academic senate of institutes of higher learning.

#### Article 6

- (1) SPME carried out through accreditation has a cycle of activities consisting of :
- a. the phase of evaluating data and information;
  - b. the phase of deciding the accreditation status and accredited rating; and
  - c. the phase of monitoring and evaluating accreditation status and accredited rating.
- (2) SPME shall be developed in a sustainable way by BAN-PT and/or LAM according to their respective authority.
- (3) Further provisions on the cycle of activities as referred to in paragraph (1) are to be provided for in a regulation of the Minister. .

#### Article 7

Data, information and contributions of SPMI and SPME shall be reported and kept by institutes of higher learning in PDDikti.

### CHAPTER III

#### DISTRIBUTION OF TASKS AND AUTHORITY

#### Article 8

- (1) The Directorate General shall have the task and authority to formulate, coordinate and implement the policies of SPM Dikti.
- (2) The National Standard Agency for Higher Education shall have the task and authority to formulate and develop higher education national standard.
- (3) The Directorate of Quality Guarantee shall have the task and authority to prepare the formulation of policies, facilities, implementation, coordination, control, monitoring, evaluation and reporting in the field of SPMI.
- (4) Institutes of higher learning have the task and authority to

- a. plan, implement, evaluate, control and develop SPMI;
  - b. formulate documents of SPMI consisting of :
    1. document of SPMI policy;
    2. document of SPMI manual;
    3. document of standard in SPMI; and
    4. document of form used in SPMI;
  - c. set up a quality guarantee unit or integrate SPMI in the management of institutes of higher learning;  
and
  - d. manage PD Dikti at the level of institute of higher learning.
- (5) The National Accreditation Agency for Institutes of Higher Learning (BAN PT) and/or Self-Reliant Accreditation Institution (LAM) shall have the task and authority to carry out SPME by accrediting institutes of higher learning and/or study programs.

#### CHAPTER IV

#### TRANSITIONAL PROVISIONS

##### Article 9

- (1) Before the National Standard Agency for Institutes of Higher Learning as referred to in Article 8 paragraph (2) is set up, the task and authority of the National Standard Agency for Institutes of Higher Learning shall be carried out by the Education National Standard Agency.
- (2) In carrying out its tasks, the National Accreditation Agency for Institutes of Higher Learning shall coordinate with the Education National Standard Agency.
- (3) Further provisions on the establishment of the National Standard Agency for Institutes of Higher Learning are to be provided for in a regulation of the Minister.

#### CHAPTER V

#### CONCLUSION

##### Article 10

When this Ministerial Regulation begins to take effect, Regulation of the Education and Culture Minister No. 50/2014 concerning Higher Education Quality Guarantee System shall be revoked and declared null and void.

Article 11

This Ministerial Regulation shall come into force as from then date of promulgation.

For public cognizance, this Ministerial Regulation shall be promulgated by placing it in the State Gazette of the Republic of Indonesia.
