MORATORIUM ON LICENSING SURVEY AND SALVAGE OF VALUABLES FROM SUNKEN SHIPS' CARGOES

(Regulation of the Maritime Affairs and Fisheries Minister No. 4/PERMEN-KP/2016 dated February 29, 2016)

BY THE GRACE OF GOD ALMIGHTY

THE MARITIME AFFAIRS AND FISHERIES MINISTER OF THE REPUBLIC OF INDONESIA
IN THE CAPACITY AS CHIEF OF THE NATIONAL COMMITTEE FOR THE SALVAGE AND
USE OF VALUABLES FROM SUNKEN SHIPS' CARGOES,

Considering:

- a. to manage valuables from sunken ships' cargoes as state asset, history and science of high value, it is necessary to improve management in a comprehensive way by prioritizing national and state interest
- b. that based on the consideration as referred to in letter a, it is necessary to stipulate a regulation of the Maritime Affairs and Fisheries Minister in the capacity as Chief of the National Committee for the Salvage and Use of Valuables from Sunken Ships' Cargoes concerning Moratorium on Licensing Survey and Salvage of Valuables from Sunken Ships' Cargoes in the Territory of the Republic of Indonesia;

In view of:

- Law No. 11/2010 on Cultural Reserve (Statute Book of 2010 No. 130, Supplement to Statute Book No. 5168);
- Law No. 23/2014 on Regional Governments (Statute Book of 2014 No. 244, Supplement to Statute Book No. 5587) as already amended several times the latest by Law No. 9/2015 (Statute Book of 2015 No. 58, Supplement to Statute Book No. 5679);
- 3. Presidential Regulation No. 7/2015 on the Organization of State Ministries (Statute Book of 2015 No. 8);
- Presidential Regulation No. 63/2015 on the Maritime Affairs and Fisheries Ministry (Statute book of 2015 No. 111);
- Presidential Decree No. 19/2007 on the National Committee for the Salvage and Use of Valuables from Sunken Ships' Cargoes as already amended by Presidential Decree No. 12/2009;

DECIDES:

REGULATION OF THE MARITIME AFFAIRS AND FISHERIES MINISTER IN THE CAPACITY AS CHIEF OF THE NATIONAL COMMITTEE FOR THE SALVAGE AND USE OF VALUABLES FROM SUNKEN SHIPS' CARGOES CONCERNING MORATORIUM ON LICENSING SURVEY AND SALVAGE OF VALUABLES FROM SUNKEN SHIPS' CARGOES

Article 1

Imposing a moratorium on licensing survey and salvage of valuables from sunken ships' cargoes

Article 2

The moratorium as referred to in Article 1 is done as follows:

- a. no permit is issued to survey and salvage of valuables from newly sunken ships' cargoes;
- b. expired permits to conduct survey and salvage of valuables from sunken ships' cargoes are not extended;
- c. valid permits to conduct survey and salvage of valuables from sunken ships' cargoes will be analyzed and evaluated by PANNAS BMKT until the permits expire; and
- d. if based on the results of analysis and evaluation as referred to in letter c violation is found, a sanction shall be imposed according to the law and regulation.

Article 3

The moratorium on licensing surveys and salvage of valuables from sunken ships' cargoes as referred to in Article 1 shall be valid until December 31, 2016.

Article 4

This Ministerial Regulation shall come into force as from the date of promulgation.

For public cognizance, this Ministerial Regulation shall be promulgated by placing it in the State Gazette of the Republic of Indonesia.
