AMENDMENT TO REGULATION OF THE TRADE MINISTER NO. 77/M-DAG/PER/12/2013 CONCERNING THE SIMULTANEOUS ISSUANCE OF BUSINESS PERMITS AND CORPORATE REGISTRATION CARDS FOR TRADE COMPANIES

(Regulation of the Trade Minister No. 14/M-DAG/PER/3/2016 dated March 2, 2016)

THE TRADE MINISTER OF THE REPUBLIC OF INDONESIA.

- a. that to help trade companies that will start their businesses, it is necessary to speed up and ease the pro cess of issuing trade business permits and corporate registration cards simultaneously;
- that based on the consideration as referred to in letter a, it is necessary to revise several provisions in Regulation of the Trade Minister No. 77/M-DAG/PER/12/2013 concerning the Simultaneous Issuance of Trade Permits and Corporate Registration Cards for Trade Companies;
- c. that based on the considerations as referred to in letters a and b, it is necessary to stipulate Regulation of the Trade Minister concerning Amendment to Regulation of the Trade Minister No. 77/M-DAG/PER/12/2013 concerning the Simultaneous Issuance of Trade Permits and Corporate Registration Cards for Trade Companies:

DECIDES:

To stipulate:

REGULATION OF THE TRADE MINISTER CONCERNING AMENDMENT TO REGULATION OF THE TRADE MINISTER NO.77/M-DAG/PER/12/2013 CONCERNING THE SIMULTANEOUS ISSUANCE OF TRADE PERMITS AND CORPORATE REGISTRATION CARDS FOR TRADE COMPANIES.

Article I

Several provisions in Regulation of the Trade Minister No. 77/M-DAG/PER/12/2013 concerning the Simultaneous Issuance of Trade Permits and Corporate Registration Cards for Trade Companies shall be amended as follows:

1. Article 3 shall be amended so that it reads as follows:

Article 3

- (1) The application as referred to in Article 2 paragraph (1) shall be filed by the executive board, the person in charge of trade company or the third party to the issuing official simultaneously by filling SIUP and TDP application form.
- (2) The application form as referred to in paragraph (1) is contained in Attachment to this Ministerial Regulation.
- (3) The application form as referred to in paragraph (1) shall be signed by the executive board or the person in charge of the trade company with adequate duty stamp.
- (4) If the application as referred to in paragraph (1) is filed by the third party, it shall be accompanied by a power of attorney with adequate duty stamp signed by the executive board or the person in charge of the trade company.
- 2. Article 5 shall be amended so that it reads as follows:

Article 5

(1) The official shall issue SIUP and TDP simultaneously no later than 2 (two) working days after the application has been received in a complete and correct way.

- (2) The SIUP and TDP as referred to in paragraph (1) shall be issued in separate documents using SIUP format and TDP format by observing Regulation of the Trade Minister concerning SIUP and the Regulation of the Trade Minister concerning TDP.
- (3) If the application is considered incomplete and incorrect, the issuing official shall issue a letter rejecting the application to the applicant no later 1 (one) working day after the application has been received.
- (4) Trade company whose application is rejected can file another application for the issuance of SIUP and TDP simultaneously according to the requirements as provided for in this Ministerial Regulation.
- (5) The simultaneous issuance of SIUP and TDP as referred to in paragraph (1) can use online corporate information system managed by the Trade Ministry.
- 3. Article 6 shall be amended so that it reads as follows:

Article 6

To develop and supervise trade companies, the issuing official shall convey any issuance of SIUP and TDP to the Head of Service office responsible for the trade sector in the form of photocopy.

Article II

This Ministerial Regulation shall come into force as from the date of promulgation.

For public cognizance, this Ministerial Regulation shall be promulgated by placing it in the State Gazette of the Republic of Indonesia.
