Article I

Attachment III to Regulation of the Finance Minister No. 213/PMK.011/2011 concerning the System of Classifying Goods and Imposing Customs Duty Tariffs on Imported Goods as already amended by

- 1. Regulation of the Finance Minister No 133/PMK.011/2013;
- 2. Regulation of the Finance Minister No 97 / PMK.010/2015;
- Regulation of the Finance Minister No 132/ PMK.010/2015, under which customs duty tariffs on the import

of goods and materials for the repair and maintenance of planes have been set shall be revised so that it becomes as contained in the attachment which is an integral part of this Ministerial Regulation.

Article II

- 1. The imposition of customs duty tariffs as referred to in Article I may be subject to evaluation according to economic developments and conditions.
- The imposition of customs duty tariffs as referred to in Article I applies to the import of goods whose import notifications have obtained the number

and date of registration from the Customs Office of entry starting from the coming into force of this Ministerial Regulation.

This Ministerial Regulation begins to take effect
 (thirty) days after the date of promulgation.

For public cognizance, this Ministerial Regulation shall be promulgated by placing it in the State Gazette of the Republic of Indonesia.
